Matt Sherman attended Hawkeye Community College in 1998 to study integrated roadside vegetation management. He interned with Doug Sheeley during the summer of 1999 in Dallas County. Matt graduated from HCC with an Associate of Applied Science degree in Natural Resources Management in May 2000. He became Roadside Manager of Allamakee County following graduation. Matt became Assistant Biologist of Dallas County in 2001, working with his mentor, Doug Sheeley. Matt died January 9, 2003 at the age of 23.

Two \$500.00 scholarships are being offered in his name because, in his short professional life, Matt exemplified what a roadside manager is. His passion for prairies and using prairie species to vegetate the landscape soon became the passion of those around him.
